Who We Are

Métis Nation–Saskatchewan (MN–S) is the democratic government built by and for Métis citizens, guided by community voices and grounded in accountability to our people. Every program, investment, and decision shared in this report reflects our responsibility to serve Métis families across our homeland.

We empower Métis families, youth, and Elders through programs and services that improve daily life in housing, health, childcare, education, culture, and more. MN–S represents more than 34,000 registered Métis citizens across 12 regions and is recognized in Canada's Constitution (Section 35) as one of three Indigenous peoples (First Nations, Métis and Inuit). Our government is led by the Provincial Métis Council, which sets our governance structure and forms the cabinet of our distinct government.

This Annual Report tells the story of a Nation in action. It reflects a year of growth, responsibility, and impact. We aim to tell our stories grounded in Métis identity, values, language, and culture. It is both a record of our progress and a reaffirmation of our commitment to walk forward together as a self-governing Métis Nation.

A Message from our Elders

In 2024, Elders' voices reaffirmed the Métis Nation–Saskatchewan's commitment to self-government and culturally relevant programs. Through gatherings and consultations, Elders emphasized traditional governance practices based on kinship, mutual responsibility, and respect. They urged that these values be embedded in all aspects of MN–S governance.

Elders shared heartfelt reflections on cultural resilience and knowledge transfer. They emphasized holding onto Métis identity, protecting our land, and maintaining community bonds through practices like hunting, fishing, and storytelling. Their collective wisdom serves as a foundation for MN–S's work, ensuring it reflects the distinct identity and lived experiences of Métis citizens.



A Message from our Youth

The youth gatherings continue to be a highlight of the year. They create a strong sense of belonging and friendship. Feedback collected from youth helps guide future programs and support services.

Looking ahead, youth are asking for more Métis-specific mental health supports and programs designed for ages 16–29, who often fall between “youth” and “adult” supports.

OUR VISION

Our vision is for MN–S to be a healthy, self-sustaining, sovereign nation that is rooted in Métis culture, language, values, and community. Our government will act in solidarity to protect and advance our traditional homeland and the rights of our citizens.

GUIDING VALUES AND PRINCIPLES

The following Guiding Principles and Core Values are at the heart of MN–S Government and give direction to the Distinctions-Based Focus Plan. These principles and values were identified in consultation with Elders and the PMC, through visiting sessions and deep listening. These principles and values highlight distinctly Métis ways of relating and acting, based on insights shared by Knowledge Keepers. The values listed reflect the beliefs that guide the MN–S Government’s behaviour, while the principles are core truths or rules that direct actions and their outcomes.

GUIDING PRINCIPLES

Inclusivity & Compassion: Creating programs that serve our diverse Métis communities.

Acceptance & Understanding Diversity: Promoting respect and empathy for all.

Integrity & Transparency: Demonstrating honesty and fairness to prioritize citizens' best interests.

Resiliency & Perseverance: Supporting Métis values, culture, and rights despite obstacles.

Strength, Hard Work & Action: A continuous effort to support an effective Government that serves the citizens of the Métis Nation in Saskatchewan.

MINISTRY & DEPARTMENTAL HIGHLIGHTS

DEPARTMENT OF Registry

This year, the MN-S Citizenship Registry met thousands of Métis people.

"The definition of Métis as adopted by Métis Nation-Saskatchewan is a person who self-identifies as Métis, is distinct from other Aboriginal peoples, is of historic Métis Nation ancestry and is accepted by the Métis Nation."

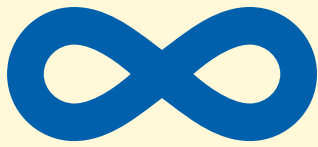
The MN-S Department of Registry supports Métis citizens in applying for and renewing citizenship cards, ensuring the process is transparent, equitable, and aligned with the MN-S Constitution. The Registry department maintains accurate citizenship records and strengthens the delivery of programs and services for Métis citizens across Saskatchewan.

On a visit to Île-à-la-Crosse, an Elder placed her hand on her new card and said, "Now my grandchildren will know who they come from." Moments like this shaped our year **helping families reclaim identity, connect to services, and take their place in our shared story.**

KEY RESULTS

- **5,352** new citizens registered
- **12,142** applicants emailed about their application status
- **1,671** renewal cards issued
- **28,052** citizens were accepted for programs and services
- **201** mobile intake sessions held across Saskatchewan
- **\$122,275** saved for applicants by ordering 4,891 genealogy certificates at no cost
- A database review identified **2,603** individuals who now hold First Nation Status and were notified they are no longer eligible for MN-S citizenship

The Registry will continue using new tools to speed up processing times and expand mobile application intake across the province.



MÉTIS NATION-SASKATCHEWAN WELCOMES 30,000TH CITIZEN

LAWRENCE AND HARRIET PARKER

“Wow!” That was Lawrence Parker’s response after becoming our Métis Nation’s 30,000th citizen. At the age of 91, Lawrence said his wife of 64 years, Harriet, became a citizen three years ago and encouraged him to apply for a card. He said MN-S has been very supportive of his health needs but more importantly, “Not many people believe I am Métis, so I wanted proof. I also want my family – 6 children, 13 grandchildren, 5 great-grandchildren and 1 grandchild on the way – to be proud Métis citizens.”

MINISTRY OF Child & Family Services

This year, the MN-S Ministry of Child & Family Services conducted 26 community sessions, 7 online sessions, and 1 online survey with 362 participants. Families, Elders, youth, and caregivers came together to build a future where Métis children can grow up surrounded by culture, language and identity. The Cultural Connections pilot program helped Métis children in provincial care reconnect with their community and identity.

During C-92 sessions, people shared stories of resilience and asked for development of a system where Métis children stay connected to their culture and community. The work is ongoing.

KEY RESULTS

- **32** C-92 community consultations held
- **Over 350** participants contributed to building a Métis-led child and family system
- **Cultural Connections** pilot supported Métis children in provincial care to reconnect with their identity and community
Cultural Connections:
- **22 children** received cultural connections support
- **50 children** identified by MSS
- Dedicated Registry worker to support registering children in care as there is an estimated **100 Métis children** in care

Education was a top priority this year, with exciting progress in Early Learning and Childcare (ELCC), K-12, and Post Secondary. Looking back at the year, our investments are making a real difference through our programs and the people they help.

Early Learning & Child Care (ELCC)

A mother in Saskatoon said her daughter came home from daycare singing a Michif song she learned that day. “She’s teaching me now,” the mother laughed. “I didn’t grow up with the language, but she will.”

Moments like this proudly shaped the year for Early Learning & Child Care. Every song, every story, every circle time became a step toward raising children who grow up knowing who they are and where they belong.

MN-S invested in programs that empower families, strengthen cultural identity, and create warm, safe spaces for children to learn and thrive. From home-visiting supports to language-rich play, ELCC reached Métis families and built momentum for major new Centres of Excellence. The Centres of Excellence will become beacons of community learning, culture, and early education for years to come.

This is how a Nation raises its future.

KEY RESULTS

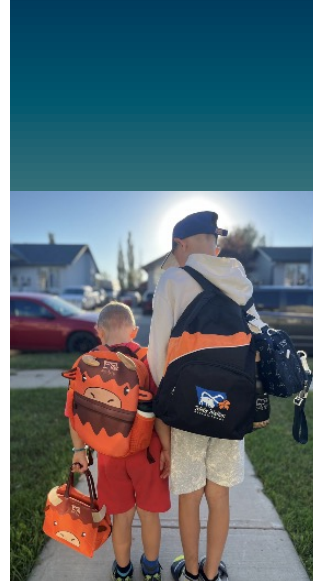
- More than **6,000 children** benefited from ELCC family support programs
- **3,185 backpacks** given as part of the Gear Up Program
- **3,120 children** received cultural packages for the Lii Bufloo Cultural Package Program
- **2,443 children** benefited from the Let’s Play Program funding
- **369 children** were supported through the Let’s Soar Program
- The Little Buffalo Reader Program supplied **1,240 children** with books
- **Over \$4.1 million** provided in childcare subsidy
- Construction continued on three new Early Learning Centres of Excellence in Prince Albert, Saskatoon, and Regina
- Families accessed cultural programming, developmental supports, and community-led learning opportunities
- ELCC strengthened partnerships with educators, Elders, and service providers across all regions

GEARING UP FOR SCHOOL CITIZEN SPOTLIGHT

The MN-S ELCC team put smiles on the faces of young Métis citizens this year, as they distributed over 3000 Gear Up for School backpacks for the 2024/2025 school year. The backpacks include a variety of school supplies needed to excel in the classroom. The team implemented a new distribution method, travelling to four locations in different regions of the province to hand out backpacks. Teaming up with registry at all locations made it possible for citizens to apply for and receive their backpacks on the spot.

MN-S is committed to helping children grow up confidently in their identity. ELCC helps build that foundation. It supports families and gives every child a strong start rooted in pride, language, and belonging.

When a community invests in its youngest citizens, the whole Nation grows stronger. MN-S will continue expanding childcare spaces, language-rich programming, and family supports.



ANGEL FAVELLE

Back-to-school season can be a financial burden when it arrives; the cost of supplies can add up quickly, especially for families with growing children. For Angelique Favelle, the Métis Nation-Saskatchewan (MN-S) Gear Up Program has been a welcome source of support and pride.

Angelique first learned about the program through the MN-S monthly newsletter. Since then, her son has eagerly looked forward to receiving his backpack each year, filled with school supplies and a gift card that help him begin the school year on par with his peers.

“For us, it’s being able to start the school year on the same foot as his fellow classmates. So instead of having, I guess, I don’t want to say substandard, but lower value school supplies he started off with the same [stuff] that 95% of his classmates are” she shared.

Beyond the practical benefit, Angelique says the program provides meaningful financial relief and celebrates Métis identity. “My child takes pride in showing off the backpack and the Métis symbols. It’s a reminder of who we are.”

Angelique appreciates the convenience of having backpacks shipped directly to families, especially for those in rural communities. She highly recommends the program to other Métis families, saying it not only supports students’ readiness for school but also fosters pride in their heritage.

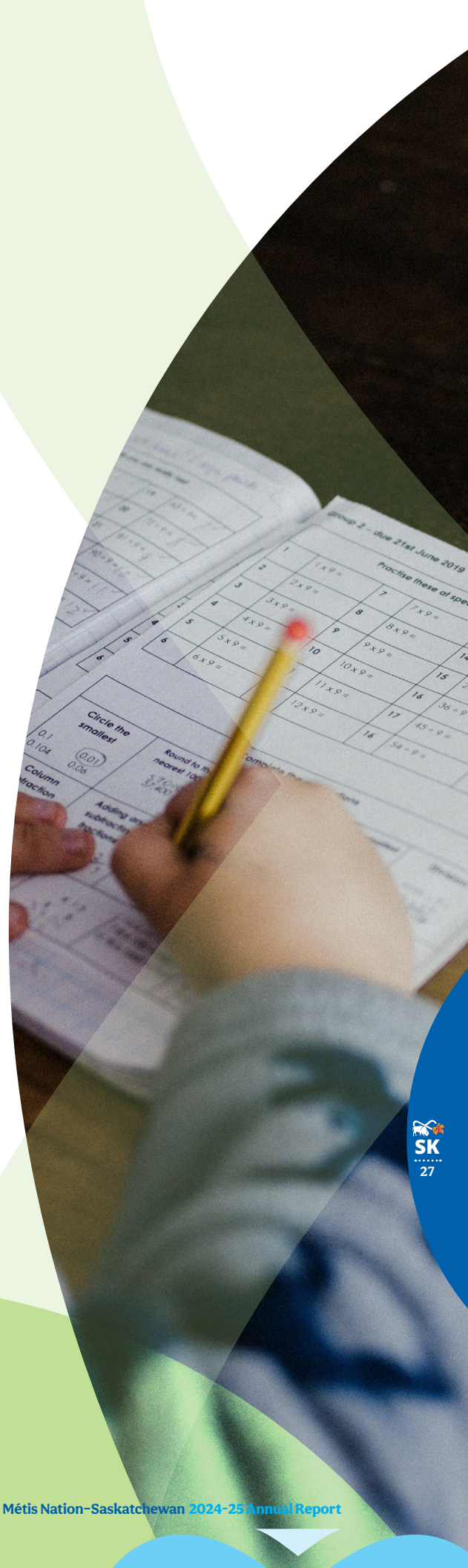
K-12 and Post Secondary

At the K-12 level, we're building the foundation for Métis-led education systems by developing a province-wide framework in collaboration with Elders, youth, educators, and community members. Ongoing work includes gathering data through conversations, interviews, surveys, and youth-specific learning tools to ensure our education supports reflect Métis voices and needs.

In collaboration with Gabriel Dumont Institute, a 10-year Post-Secondary Education Agreement with the Government of Canada provides annual funding to students and has continued to grow, directly benefiting Métis learners. This year, we supported 267 graduates: 136 from high school, 52 in trades and diplomas, 61 with bachelor's degrees, 13 at the master's level, and 2 PhD graduates. To celebrate these achievements, we delivered 270 Graduation Sash boxes to Métis graduates across all regions.

We also expanded partnerships, including a new Citizenship Agreement with Saskatchewan Polytechnic to open doors for Métis students, and teamed up with SHAD Canada to offer a six-week STEM enrichment program that encourages more Métis youth to explore post-secondary pathways.

All of these efforts show how we are helping young people and building a strong future for Métis Nation-Saskatchewan, while respecting our history and taking care of our community today.



Economic Development

A young Métis business owner in Prince Albert said, “When the Nation believes in you, you believe in yourself.”

Many Métis entrepreneurs shared that same feeling over 2024-25. From family-run trades to tourism ventures along the Louis Riel Trail, Economic Development & Tourism focused on creating a stronger procurement policy to keep MN-S spending within the Nation. The Métis Business Registry and new tourism work connected history, culture, and economic opportunity for communities across Saskatchewan.

MN-S is growing a strong Métis economy.

KEY RESULTS

- Seven Stars Energy Project ‘provided a **\$100M loan guarantee** and partnerships with 5 other First Nations
- The Métis Business Registry grew by **49%**, reaching nearly **200 businesses**
- A new procurement policy ensured MN-S dollars support verified Métis businesses
- Tourism projects, including upgrades to the Louis Riel Trail, strengthened cultural connection and economic potential
- More entrepreneurs accessed support, mentorship, and business visibility through MN-S programs

Métis Nation-Saskatchewan continues to advocate for Métis business inclusion at both the provincial and federal levels to ensure that Saskatchewan Métis Workforce Registry registrants are considered in key procurement activities undertaken by our governments.

A strong Métis economy lifts families, supports communities, and creates opportunities that benefit everyone in the province. When Métis businesses grow, so does our Nation’s independence, resilience, and local prosperity. Our entrepreneurs become role models. Our tourism sites become places of experiential learning and pride. And our investments become stepping stones for the next generation of youth leaders.

MN-S will continue investing in Métis-owned businesses, tourism infrastructure, and economic partnerships that foster prosperity and open long-term career and leadership paths for Métis citizens.

BONSAI WELDING CONTINUES TO EXPAND

Daniel Giasson, creator and owner of Bonsai Welding Ltd. in Shaunavon, Saskatchewan, and father of three, grew up on a farm in Southwest Saskatchewan. With a strong work-ethic and entrepreneurial aspirations, Daniel established Bonsai Welding Ltd. in 2010 and later incorporated the company in 2012. Since its outset, the company has continued to expand, offering a wide variety of services to accommodate client needs, including vacuum trucks, water trucks, tanker trucks, welding, mechanics, oil field services, and helium services. Bonsai Welding Ltd. has left its mark across Western Canada, supporting drilling rigs and operations and venturing as far as transporting helium into the United States.

Looking ahead, Daniel hopes to play a major role in Saskatchewan’s evolving energy landscape and to continue to contribute to the region’s economic growth stating, “We just try to do our part to shine a positive light on being a Métis owned business and be proud of it.”

As a direct result of Bonsai Welding Ltd.’s community-based and customer focused approach, they have been able to create job opportunities for Shaunavon locals and Métis citizens. As a Métis entrepreneur, Daniel’s determination has created a reliable income for dozens of employees, has helped diversify the local economy, and has empowered his community.

As words of guidance for future Métis entrepreneurs Daniel says, “You’re going to have to have some patience. Patience with yourself, patience with the process. There’s always going to be tough days, [...] but having something to show for your efforts at the end of the day is pretty special.”



MINISTRY OF Health

On a cold morning in Regina, a young man approached the Wiichihew Li Moond (Walking With Them) outreach van. He wasn't sure what he needed – only that he didn't want to be alone. A worker handed him a warm drink, listened, and said, “You're not invisible here. You're with us.”

Métis Nation–Saskatchewan Ministry of Health and Mental Health and Addictions (HMHA) is committed to enhancing the health and well-being of Métis individuals, families, and communities by fostering culturally safe, inclusive, and equitable health services collaboration. Through engagement with partners and community leaders, the Ministry aims to address health disparities, support mental wellness, and promote holistic approaches to care that reflect the unique histories, values, languages, and strengths of Métis people.

Our Ministry believes that all Métis people deserve access to high-quality healthcare across their lifetime. Equitable, accessible, and consistent care led to better overall health outcomes for all. The foundation of our approach to health and well-being is rooted in relational care and a distinctions-based approach that grounds our work in Métis culture and values.

Our Ministry meets citizens where they are at and walks beside our citizens in their health and wellness journey.

INAUGURAL MÉTIS HEALTH CONFERENCE A SUCCESS

Kiishpin kwaayeshpishkaapamishooyaahk naawut kinwaysh ka pimaatishinaan is the Michif way of saying, “If we take care of ourselves in a good way, we'll live a long life.”

Almost 500 people came together in Saskatoon in February 2025 for a productive exchange of ideas around best practices for long-term and palliative care for Métis people. The theme of the inaugural gathering was ‘Taking Care Together: Aging into Well-Being’. During the two-day conference, MN–S and the Saskatchewan Health Authority renewed their commitment to work together on improving the health status of Métis people in the province.

Wellness grows when people feel seen, supported, and connected to their culture. All the programs available from the MN–S Ministry of Health are designed to create safer paths to healing and ensure the next generation has access to services that honour cultural responsiveness and care.

MN–S will continue expanding culturally grounded health services and resources, land-based healing opportunities, addictions support, and family care.

KEY RESULTS

- **1,830 citizens** accessed counselling through the Mental Wellness Support Program
- **28,006 individuals** received street-level support through Wiichihew Li Moond (Walking With Them) outreach in Saskatoon, Prince Albert, and Regina
- **21 citizens** received help transitioning from federal institutions through the Métis Reintegration Support Program
- Wellness Through Our Lands: Miyooayaan Aansaamb program supported **59 Métis Locals** to develop and provide their own land-based healing programs and activities that supported mental health and well-being in community, reaching more than **2,000 citizens**
- Provided **\$478,000 to 333 families** with Funeral and Bereavement assistance. This program has been able to support citizens and their families by easing the burden of funeral expenses during the difficult time of losing a loved one, and ensure citizens can travel to attend family funerals, transport the bodies of their loved ones to their home communities, and receive Métis-made urns and sashes for end of life ceremonies
- **4,059 citizens** received Medical Travel Assistance. This program has successfully connected citizens to supports and resources while accessing care outside of their communities, including out of province trips, ensuring that families do not have to worry about travel costs, accommodations or access to food under already stressful circumstances
- The HMHA Métis Midwifery and Birthing Centre team successfully collaborated with the Saskatchewan College of Midwives to make amendments to the Saskatchewan Midwifery Act to recognize Indigenous community midwifery programs and communal practices of care
- **Nearly 500 people** gathered at Taking Care Together: Aging into Wellbeing, the first Métis health conference focused on Métis-distinct approaches to aging well. Conference functioned as the debut screening of a video series between MN-S and Healthcare Excellence Canada, capturing the unique challenges faced by citizens and bringing awareness to culturally responsive patient safety education
- Hosted **17 Tea and Talks**: Li Tii Minihkwaytaak Piikishkwaytaak webinars, on topics ranging from understanding tuberculosis; Métis experiences with long-covid; and early detection of cancers
- This was a year filled with building trust, expanding services, and creating Métis-led spaces for healing focused on dignity, connection and care for the whole person. Highlights range from new mobile counselling and addictions support to the first Métis-specific health conference.

MINISTRY OF Housing & Homelessness

When a Métis couple in Yorkton received the call that their homeownership grant was approved, they sat at their kitchen table and cried. “We never thought we’d own something,” they said. “Now our kids will have a place that’s ours.”

It's stories like this that share the deep level of security that stable housing truly provides. This year, MN-S helped hundreds of families secure housing, make home repairs to unsafe conditions, make energy-efficient upgrades, and find stability in times of crisis.

And for those experiencing homelessness, MN-S worked to bring services, data, and solutions to communities that have often been overlooked.

KEY RESULTS

- **320 citizens** bought their first home
- **240 urgent home repairs** completed
- **296 energy-efficient upgrades** supported
- More than **1,400 applications** received for the Home Efficiency Program
- MN-S completed its first rural Point-in-Time count to better understand homelessness outside major cities
- **\$13M in grants** to citizens
- **\$10.7M invested** in capital projects
- **\$5.5M invested** in community housing programs

A safe home changes everything. It provides families with security, strengthens communities, and protects the next generation from instability and harm. When citizens have secure housing, they can focus on education, employment, health and wellness, and cultural connection.

A stable home is a step toward self-determination. MN-S will continue its commitment to expanding housing supports, improving repair programs, and developing more culturally informed responses to homelessness in both rural and urban areas.



2024 SASKATCHEWAN HOUSING AND HOMELESSNESS CONFERENCE A SUCCESS

The 2nd annual MN–S Saskatchewan Housing and Homelessness conference brought community partners, building professionals, and concerned citizens together to act against the growing homelessness crisis in our province.

The conference focused on education, funding opportunities, dialogue sessions, and idea sharing. Participants walked away with a deeper understanding of strategic priorities and what is required to achieve collective action in our communities.

MINISTRY OF

Lands & Environment

At sunrise on the North Saskatchewan River, a Métis Guardian paused to listen – not for danger, but for guidance. “The land knows us,” he said. “Our job is to take care of it in return.”

MN–S Ministry of Lands & Environment worked closely with communities across the homeland to honour the relationship we have with our land. From the Northern Region II Impact Benefit Agreement to climate change workshops and blueberry monitoring projects, our citizens are building a sustainable future grounded in traditional knowledge and science.

Guardians trained with Elders, youth learned from knowledge keepers, and local communities stepped forward to protect the lands that carry our stories.

KEY RESULTS

- Expanded community-led environmental stewardship projects
- Strengthened Guardians programming rooted in traditional knowledge
- Advanced policy and harvesting rights discussions
- Supported conservation, monitoring, and land protection initiatives across regions

Taking care of the land is taking care of our children. Stewardship protects food sources, cultural practices, and our ability to live well as Métis people. This work ensures future generations inherit lands that are healthy, respected, and connected to our history. The Ministry will continue building Métis-led environmental programs and advancing harvesting rights grounded in law, culture, and community experience.



PROVIDING SECURITY FOR MÉTIS FAMILIES

Over the summer of 2024, MN-S sent out 500, 72-hour emergency preparedness kits to Métis citizens across the province through the Emergency Preparedness Kit Giveaway. Each kit is designed to support a family of four for three days in the event of an emergency. This first-time initiative focused on regions where the need for preparedness is most critical, ensuring our citizens have the tools and resources to stay safe and resilient.

The kits are just one of the steps our MN-S government takes in its commitment to support Métis communities and enhance their preparedness to natural disasters or climate-related events, such as wildfires, flooding or severe storms.

MINISTRY OF Language

At a summer language camp, a boy proudly introduced himself in Michif for the first time. His kokum wiped a tear and whispered, “That’s our language coming home.”

Language is at the heart of Métis identity. The Ministry of Language worked to revitalize all languages Métis people speak, and strengthen cultural identity across the Nation. Elders taught youth. Youth inspired Elders. Language nests, cultural camps, community classes, and digital tools created learning spaces full of laughter, courage, and pride. Families found new ways to bring culture into daily life. Every new learner adds another voice to a living, growing Michif.

KEY RESULTS

- Early Learning Language programs across MN–S regions
- Language camps and seasonal gatherings grounded in Métis history and teachings
- Digital and physical resources and tools developed to support learning at home and in schools
- Elders, youth, and educators working together to safeguard identity

Language is memory, identity, and future. When children speak Michif, they carry our ancestors’ voices and ensure the language lives on. Cultural programs build pride and connection that last a lifetime. MN–S will continue expanding Michif learning opportunities and creating new tools that help families learn together.



CUMBERLAND HOUSE CELEBRATES 250 YEARS

The oldest community in Saskatchewan, Cumberland House celebrated 250 years in 2024. This historic Métis community honoured its history with a Cultural Feast and Cultural Village, featuring storytelling, sharing of Métis history, museum exhibits, interpretive trails, and a variety of competitions and nightly entertainment. Cumberland House has been a cornerstone of Métis heritage, and the 250-year celebration is our moment to reflect on our past, celebrate our traditions, and envision a brighter future. As we continue to our Nation, MN-S is committed to preserving our rich Métis culture and language that has thrived for centuries.

MINISTRY OF

Métis Rights & Justice

When the Supreme Court of Canada upheld MN-S's right to pursue judicial review, an Elder said, "Our ancestors fought for this. Today, we honour them."

This year marked historic progress with Métis Nation–Saskatchewan exercising the inherent right of self-government. Through court victories, continuing work on constitutional reforms, community engagement, and ongoing Treaty negotiations with Canada, MN-S continued building the laws and structures that reflect our rights as a distinct Nation. The work is grounded in the voices of citizens across Saskatchewan.

KEY RESULTS

- **Constitutional Reform (Voice of the People):** Ongoing engagements across Saskatchewan identified six priority amendments to the MN-S Constitution, including adding self-government language and creating a Métis Judiciary. These amendments were endorsed by the Provincial Métis Council.
- **Building a Métis Justice System:** The draft Kwayaskastasowin Judiciary Act was developed to create a justice system designed by and for Métis people.
- Landmark win at the Supreme Court of Canada affirming MN-S's right to bring forward Aboriginal title and harvesting issues
- **16 Provincial Métis Council** meetings and **3 MNLA** sittings
- Progress on Treaty negotiations with Canada
- Steps taken to lift the stay on the historic MN-S land claim
- Agreements advanced with University of Regina, Parks Canada, and others

Self-government is achieved through generations of courage, persistence, and unity. This progress strengthens Métis rights and governance today, while ensuring future generations inherit a Nation that is recognized, respected, and self-determined.

MN-S will continue advancing negotiations, engaging the community, and building Nation-led governance structures that honour Métis law and tradition.

DEPARTMENT OF Women & Gender Equity

A Métis mother met with the Family Information Liaison Unit (FILU) and said, “For the first time, someone listened without judgment.”

The Department for Women & Gender Equity worked alongside families, survivors, and 2SLGBTQIA+ citizens to ensure Métis women and gender-diverse people have an equal voice and safe, culturally informed support.

Families affected by Missing and Murdered Indigenous Women, Girls and 2S+ (MMIWG2S+) cases received guidance, information, and compassion. Programs uplifted Métis women’s leadership and created safer spaces for healing and expression.

KEY RESULTS

- Family Information Liaison Unit (FILU) supported families affected by MMIWG2S+ cases, helping them find information and healing
- Community programs and partnerships expanded support for Métis women and 2SLGBTQIA+ citizens
- Increased focus on safety, culture, and empowerment in regional programming



A MÉTIS MATRIARCH CELEBRATES A MILESTONE

Born and raised in the Lac Pelletier area, MN–S citizen Cecile Blanke now lives in Swift Current. Cecile is an author, was a local president for the Ponteix/Swift Current area, and a Métis Senator. On November 10, 2024 Cecile celebrated her 90th birthday. MN–S celebrates and honours the women, girls, and 2SLGBTQIA+ citizens of our Nation.

DEPARTMENT OF Youth

At a youth gathering last summer, a young man from Buffalo Narrows said, “This is the first place I felt like people get me.” Heads around the circle nodded – they understood.

This past year, youth gatherings created space for connection, confidence, and identity. Young Métis people came together to learn, share, make friends, and see themselves as future leaders of the Nation. Whether through sport, culture, education, or community leadership, the Youth Ministry opened doors and lifted voices that can go unheard.

KEY RESULTS

- Regional, provincial, and national youth gatherings across multiple communities
- More young people accessing culture, sport, and leadership opportunities
- Youth feedback directly guiding future MN-S programming

MN-S believes in the power of investing in our youth and listening to them to ensure they feel seen and supported, helping them grow into strong, confident leaders. These programs reflect our belief that Métis youth deserve space to explore who they are, build pride, and shape the future of the Nation.

Youth have asked for more Métis-specific mental health supports and programming for ages 16–29, who often fall between youth and adult services. MN-S will continue engaging with youth, exploring focus group sessions to improve engagement and build pathways for their success.

MN-S MÉTIS YOUTH LEADERSHIP AWARD

Julia Aussant was the 2024 MN-S Métis Youth Leadership Award recipient. She is a youth leader, a mentor, and extremely proud of her Métis heritage. She was presented this award during Back to Batoche Days 2024 for her dedication and work at Local #11. Julia was recognized for her ability to share her knowledge and generate enthusiasm among her peers to embrace and reconnect to their culture and Michif language. We look forward to seeing her bright future as a Métis citizen.

Management's Responsibility

To the Citizens of Métis Nation - Saskatchewan Secretariat Inc.:

Management is responsible for the preparation and presentation of the accompanying non-consolidated financial statements, including responsibility for significant accounting judgments and estimates in accordance with Canadian accounting standards for not-for-profit organizations. This responsibility includes selecting appropriate accounting principles and methods, and making decisions affecting the measurement of transactions in which objective judgment is required.

In discharging its responsibilities for the integrity and fairness of the non-consolidated financial statements, management designs and maintains the necessary accounting systems and related internal controls to provide reasonable assurance that transactions are authorized, assets are safeguarded and financial records are properly maintained to provide reliable information for the preparation of non-consolidated financial statements.

The Provincial Métis Council (the "Council") is responsible for ensuring that management fulfills its responsibility for financial reporting and is ultimately responsible for reviewing and approving the non-consolidated financial statements. The Council carries out its responsibility principally through its Finance Committee. The Finance Committee is appointed by the Council and meets periodically with management and the members' auditors to review significant accounting, reporting and internal control matters. Following its review of the non-consolidated financial statements and discussions with the auditors, the Finance Committee reports to the Council prior to its approval of the non-consolidated financial statements. The Committee also considers, for review by Council and approval by the Métis Nation Legislative Assembly, the engagement or re-appointment of the external auditors.

MNP LLP is appointed by the Citizens to audit the non-consolidated financial statements and report directly to them; their report follows. The external auditors have full and free access to, and meet periodically and separately with, both the Council and management to discuss their audit findings.

INDEPENDENT AUDITOR'S REPORT

To the Citizens of Métis Nation - Saskatchewan Secretariat Inc.:

Opinion

We have audited the non-consolidated financial statements of Métis Nation - Saskatchewan Secretariat Inc. ("MN-S"), which comprise the non-consolidated statement of financial position as at March 31, 2025, and the non-consolidated statements of operations, changes in fund balances, cash flows and the related schedules for the year then ended, and notes to the non-consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying non-consolidated financial statements present fairly, in all material respects, the non-consolidated financial position of MN-S as at March 31, 2025, and the results of its non-consolidated operations and its non-consolidated cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Non-Consolidated Financial Statements section of our report. We are independent of MN-S in accordance with the ethical requirements that are relevant to our audit of the non-consolidated financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other Matter

The non-consolidated financial statements for the year ended March 31, 2024 were audited by another auditor who expressed an unmodified opinion on those non-consolidated financial statements on November 8, 2024.

Responsibilities of Management and Those Charged with Governance for the Non-Consolidated Financial Statements

Management is responsible for the preparation and fair presentation of the non-consolidated financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of non-consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the non-consolidated financial statements, management is responsible for assessing MN-S's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate MN-S or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing MN-S's financial reporting process.

Auditor's Responsibilities for the Audit of the Non-Consolidated Financial Statements

Our objectives are to obtain reasonable assurance about whether the non-consolidated financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these non-consolidated financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the non-consolidated financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of MN-S's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on MN-S's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the non-consolidated financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause MN-S to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the non-consolidated financial statements, including the disclosures, and whether the non-consolidated financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

1. Nature of operations

Métis Nation - Saskatchewan Secretariat Inc. ("MN-S") was incorporated under The Métis Act of Saskatchewan as a body corporate without share capital and is deemed to have status of a member within the meaning of The Non-profit Corporations Act, 2022 and thus is exempt from taxes.

MN-S's purpose is to undertake activities that strive to recognize the political, legal and constitutional rights of the Métis people in Saskatchewan. MN-S represents the province's Métis citizens. The Métis Nation Legislative Assembly is the governing authority of MN-S and has the authority to enact legislation, rules, and resolutions governing the affairs and conduct of the Métis in Saskatchewan.

2. Significant accounting policies

The non-consolidated financial statements have been prepared in accordance with Canadian accounting standards for not for-profit organizations set out in Part III of the CPA Canada Handbook - Accounting, as issued by the Accounting Standards Board in Canada, which are part of Canadian generally accepted accounting principles, and include the following significant accounting policies:

Basis of presentation

MN-S is required to report its controlling interest in SaskMétis Economic Development Corporation ("SMEDCO"). MN-S has chosen to report the controlled entity (and the subsidiary) by means of providing note disclosure in relation to each entity.

MN-S is the sole shareholder of SMEDCO and this investment is accounted for at cost.

Interest earned from cash is recognized as revenue when earned.

MN-S follows the restricted fund method of accounting for contributions, and maintains four funds: Unrestricted Fund, Restricted Fund, Investment in Tangible Capital Assets Fund and Endowment Fund.

The Unrestricted Fund reports MN-S's revenue and expenses related to administrative and operating activities.

The Investment in Tangible Capital Assets Fund reports MN-S's acquisitions and improvement of tangible capital assets, as well as the amortization of MN-S's tangible capital assets.

The Endowment Fund reports MN-S's principal amount of the externally restricted endowment contributions which are maintained in perpetuity. Investment income earned on resources of the Endowment Fund is reported in the Endowment Fund. Gains and losses on disposals of investments are reflected in the Endowment Fund.

The Restricted Fund reports MN-S's use of externally restricted funds, including funding from various Government of Canada departments to support program initiatives led by MN-S.

Cash and cash equivalents

Cash and cash equivalents include balances with banks and short-term investments with maturities of three months or less.

Tangible capital assets

Purchased tangible capital assets are recorded at cost. Contributed tangible capital assets are recorded at fair value at the date of contribution plus all costs directly attributable to the acquisition.

2. Significant accounting policies (Continued from previous page)

Leasehold improvements are amortized on a straight-line basis over the remaining term of the lease, including one renewal option. Artwork is not amortized as it is considered to have an indefinite useful life. Buildings under construction are not amortized until such time as they are available for use. Tangible capital assets acquired during the year but not placed into service are not amortized in the year of acquisition.

Amortization is provided using the declining balance method at rates intended to amortize the cost of assets over their estimated useful lives.

Long-lived assets

Long-lived assets consist of tangible capital assets and biological assets. Long-lived assets held for use are measured and amortized as described in the applicable accounting policies.

MN–S writes down long-lived assets held for use when conditions indicate that the group of assets no longer contribute to MN–S’s ability to provide goods and services. The assets are also written-down when the value of future economic benefits or service potential associated with the group of assets is less than its net carrying amount. When MN–S determines that a long-lived asset is impaired, its carrying amount is written down to the asset’s fair value. Any subsequent recovery is not recorded.

Biological assets

Biological assets consist of a herd of bison and are recorded at cost. Costs includes the cost to acquire new bison and feed costs for calves or yearlings. MN–S manages its bison herd on a collective basis to maintain the collective productive capacity indefinitely. Accordingly, these assets are considered to have an indefinite useful life and are not subject to amortization.

Revenue recognition

MN–S uses the restricted fund method of accounting for contributions. Restricted contributions and externally restricted investment income for which there is a corresponding restricted fund are recognized as revenue of the Restricted Fund when received or receivable. All other restricted contributions are recognized as revenue of the Unrestricted Fund in accordance with the deferral method, because there is not an appropriate restricted fund. Under the deferral method, restricted contributions are recognized as revenue in the year in which the related expenses are made.

Unrestricted contributions are recognized as revenue of the Unrestricted Fund in the year received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Endowment contributions are recognized as revenue in the Endowment Fund.

Restricted investment income earned on Endowment Fund resources is recognized as revenue in the related fund. Unrestricted investment income is recognized as revenue in the General Fund when earned.

2. Significant accounting policies (Continued from previous page)

Allocation of expenses

MN-S incurs administrative costs throughout the year that are shared between various programs and departments. For the purposes of these non-consolidated financial statements, MN-S allocates these costs to the various restricted and unrestricted funds based on a maximum of 15% of the eligible expenditures attributed to each of the respective funds. These allocations are not subject to review by the main funder of the non-consolidated financial statements, and are used to fund other, non-specified expenditures, such as tangible capital additions.

Employee future benefits

MN-S's employee future benefit program consists of a defined contribution pension plan. MN-S's obligation under the plan is limited to making regular payments to the plan to match contributions made by employees for current services.

MN-S's contributions to the defined contribution plan are expensed as incurred. Salaries and employee benefits includes pension contributions of \$1,246,460 (2024 - \$982,702).

Financial instruments

MN-S recognizes financial instruments when MN-S becomes party to the contractual provisions of the financial instrument.

Arm's length financial instruments

Financial instruments originated/acquired or issued/assumed in an arm's length transaction ("arm's length financial instruments") are initially recorded at their fair value.

At initial recognition, MN-S may irrevocably elect to subsequently measure any arm's length financial instrument at fair value. MN-S has not made such an election during the year.

MN-S subsequently measures investments in equity instruments quoted in an active market, at fair value. Fair value is determined by published price quotations. All other financial assets and liabilities are subsequently measured at amortized cost.

Transaction costs and financing fees directly attributable to the origination, acquisition, issuance or assumption of financial instruments subsequently measured at fair value are immediately recognized in excess of revenue over expenses. Conversely, transaction costs and financing fees are added to the carrying amount for those financial instruments subsequently measured at cost or amortized cost.

Related party financial instruments

MN-S has no related party financial instruments required to be recognized at fair value.

All related party financial instruments are measured at cost on initial recognition. When the financial instrument has repayment terms, cost is determined using the undiscounted cash flows, excluding interest, dividend, variable and contingent payments, less any impairment losses previously recognized by the transferor. When the financial instrument does not have repayment terms, but the consideration transferred has repayment terms, cost is determined based on the repayment terms of the consideration transferred. When the financial instrument and the consideration transferred both do not have repayment terms, the cost is equal to the carrying or exchange amount of the consideration transferred.

2. Significant accounting policies (Continued from previous page)

At initial recognition, MN–S may elect to subsequently measure related party debt instruments that are quoted in active market, or that have observable inputs significant to the determination of fair value, at fair value.

Financial instruments are initially measured at cost and subsequently measured using the cost method less any reduction for impairment.

Transaction costs and financing fees directly attributable to the origination, acquisition, issuance or assumption of related party financial instruments are immediately recognized in excess of revenue over expenses.

Financial asset impairment

MN–S assesses impairment of all its financial assets measured at cost or amortized cost. MN–S groups assets for impairment testing when available information is not sufficient to permit identification of each individually impaired financial asset in the group. Management considers whether the issuer is having significant financial difficulty in determining whether objective evidence of impairment exists. When there is an indication of impairment, MN–S determines whether it has resulted in a significant adverse change in the expected timing or amount of future cash flows during the year.

Financial instruments (Continued from previous page)

With the exception of related party debt instruments initially measured at cost, MN–S reduces the carrying amount of any impaired financial assets to the highest of: the present value of cash flows expected to be generated by holding the assets; the amount that could be realized by selling the assets at the statement of financial position date; and the amount expected to be realized by exercising any rights to collateral held against those assets.

For related party debt instruments initially measured at cost, MN–S reduces the carrying amount of the asset (or group of assets), to the highest of: the undiscounted cash flows expected to be generated by holding the asset, or group of similar assets, excluding the interest and dividend payments of the instrument; the present value of cash flows expected to be generated by holding the assets; the amount that could be realized by selling the assets at the statement of financial position date; and the amount expected to be realized by exercising any rights to collateral held against those assets.

Any impairment, which is not considered temporary, is included in current year excess of revenue over expenses.

MN–S reverses impairment losses on financial assets when there is a decrease in impairment and the decrease can be objectively related to an event occurring after the impairment loss was recognized. The amount of the reversal is recognized in excess of revenue over expenses in the year the reversal occurs.

Measurement uncertainty (use of estimates)

The preparation of non-consolidated financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the non-consolidated financial statements, and the reported amounts of revenues and expenses during the reporting period.

Accounts receivable are stated after evaluation as to their collectability and an appropriate allowance for doubtful accounts is provided where considered necessary.

Amortization is based on the estimated useful lives of tangible capital assets.

The amount of grant funding recognized as revenue in the year is dependent upon estimates by management as to the extent the related activities of MN-S meet the requirements of the various funding agreements for which MN-S has been approved. Final determinations as to the amounts of grant funding earned are made by responsible parties at the various governmental organizations who have entered into funding agreements with MN-S, based on their evaluation of the reports they receive from MN-S. Differences may exist between the amounts management estimates as having been earned versus the amounts determined as payable to MN-S by other parties to the funding agreements. Recovery or surplus funding notices are typically received subsequent to the funding year to which they relate. Certain contributions specify that unexpended amounts remaining at the completion of the projects must be returned and accordingly are recorded as a reduction in funding and as a payable in the year this is determined.

These estimates and assumptions are reviewed periodically and, as adjustments become necessary they are reported in excess of revenue over expenses in the periods in which they become known.

3. Marketable securities

The guaranteed investment certificate had an interest rate of 5.60% and matured in December 2024.

Upon maturity, MN-S invested the proceeds into a high interest savings account. This decision was based on anticipated short-term liquidity needs and the desire to maintain accessibility for upcoming capital transactions. The high interest savings account is classified as a cash equivalent due to its immediate availability and minimal risk of changes in value.

As a result, \$931,611 in outstanding invoices related to the MNC have been included in the allowance for doubtful accounts. The amounts are non-interest bearing and have no specific terms of repayment.

Provincial Métis Regions have balances included above as, MN-S assists managing regional expenses therefore balances fluctuate based on timing of payments near year-end.

11. Related party transactions

During the year, MN-S entered into the following transactions with related parties:

MN-S is related by virtue of shared economic interest to each of its 12 regions and Les Filles de Madelaine Secretariat Inc. (LFDM) and Provincial Métis Youth Council (PMYC). During the year, MN-S expensed \$1,923,368 (2024 - \$1,587,603) to the various regions and LFDM in the form of regional capacity and program funding.

MN-S is related to Gabriel Dumont Institute of Native Studies and Applied Research Inc. (GDI) by virtue of shared economic interest and common members acting in a governance capacity. During the year, MN-S expensed \$8,433,152 (2024 - \$12,367,800) in payments to GDI to facilitate an agency relationship, whereby GDI will administer programming on behalf of MN-S, namely the Métis Nation - Saskatchewan Post-Secondary Education Program. Specified funding for this program amounted to \$8,910,000 (2024 - \$8,910,000) in fiscal 2025. MN-S also expensed \$nil (2024 - \$3,457,800) in payments to GDI to facilitate an agency relationship, whereby GDI will administer bursaries on behalf of MN-S to eligible MN-S postsecondary students. During the year, MN-S received funding from Indigenous Skills and Employment Training (ISET) and entered an agreement with GDI to provide \$13,994,649 (2024 - \$nil) to develop and deliver Métis student-specific programs. Other various expenses of \$13,000 (2023 - \$6,196) were also paid in the current year.

MN-S is related to SMEDCO by virtue of MN-S being the sole shareholder. During the year, MN-S expensed an insignificant amount in payments to SMEDCO.

MN-S is related to Muskwa Development Corporation ("Muskwa"), a subsidiary of SMEDCO by virtue of MN-S being the sole shareholder of SMEDCO. During the year, MN-S expensed \$nil in payments to Muskwa.

MN-S is related to Association of Métis Capital Corporations, a federal corporation incorporated under the Canada Not-for profit Corporations Act, by virtue of SMEDCO holding 25% of the voting shares. SMEDCO elected to account for its investment in the jointly controlled enterprise using the cost method. The carrying value amount is \$nil which corresponds to the initial cost. There were no transactions with this related party during the year.

MN-S is related to Northern Research Group Inc. ("NRG") by virtue of MN-S being the sole shareholder. During the year, MN-S expensed \$177,710 (2024 - \$1,184,269) in payments to NRG for consulting services.

MN-S was related to Provincial Métis Housing Corporation ("PMHC") by virtue of shared economic interest as well as common members acting in a governance capacity. MN-S took over administration of two funding agreements with Employment and Social Development Canada (ESDC) in fiscal 2022 and subsequently the operations of PMHC since fiscal 2023. During fiscal 2024, MN-S signed agreements, effective September 25, 2024, with Saskatchewan Housing Corporation ("SHC") to take

over the remaining assets and liabilities in PMHC. PMHC was then dissolved during fiscal 2025. The net book value of the assets of the transfer was \$566,052 and the remaining liabilities, as a forgivable loan to the SHC, was \$535,026. The forgivable loan is amortized monthly and will end on January 1, 2032 (see Note 14 for details).

These transactions are in the normal course of operations and are measured at the exchange amount, which is the amount of consideration established and agreed upon by the related parties.

15. Economic dependence

MN-S's primary source of revenue are grants and service agreements received from various agencies and departments of the federal government. The grant funding can be cancelled if MN-S does not observe certain established guidelines. MNS's ability to continue viable operations is dependent upon maintaining its compliance with the criteria within the various government funding guidelines. As at the date of these non-consolidated financial statements MN-S believes that it is in compliance with the guidelines.

16. Comparative figures

Certain comparative figures have been reclassified to conform with current year presentation.

The Guaranteed Investment Certificate maturity date of December 2024 met the criteria for classification as a current asset in the prior year. As such, this has been reflected as a current asset in the prior year comparative non-consolidated financial statements.

17. Contingencies

i) In the normal conduct of operations, there are various pending claims by and against MN-S. Litigation is subject to many uncertainties, and the outcome of individual matters is not predictable with assurance. In the opinion of management, based on the advice and information provided by its legal counsel, final determination of these various litigations will not materially affect MN-S's non-consolidated financial position or results of operations.

ii) Under the requirements of the funding arrangements with the Government of Canada, any amount of flex funding set out in the payment plan is an overpayment that must be paid back when the recipient has not spent the funds, as permitted by this agreement, by the expiry or termination of this agreement. Any amount that MN-S is required to pay back is a debt due to the Government of Canada which becomes payable when the Government of Canada notifies the recipient of the debt. It is management's assessment that the full amount of funding will be spent by the expiry or termination of each of the flex funding agreements.

iii) Under the requirements of the funding arrangements with the Government of Canada, any amount of fixed funding set out in the payment plan is an overpayment that must be paid back when the recipient has not provided the required reports concerning the funds, the amount is spent on an expense that is not an eligible cost of the specified initiative or the amount is not spent in the fiscal year for which it was provided. The recipient is released from the obligation to repay an unexpected fixed amount when the recipient has fulfilled all of the delivery requirements of the agreement for the specified initiative, or in accordance with a plan for spending the amount that is submitted by the recipient to the federal government within 120 days of the end of the fiscal year in which the amount was to have been spent and the recipient reports on the use of the amount as required by the reporting guide. Program approval for carry forward has been approved for all fixed funding agreements for the fiscal year ended March 31, 2025.

iv) These non-consolidated financial statements are subject to review by MN-S's funding agencies. It is possible that adjustments could be made based on the results of their reviews. Any forfeited funding will be recorded in the year the amounts are determined.

v) In 2025, MN-S signed an agreement with the Saskatchewan Housing Corporation. The agreement provided the PMHC - Yorkton building by way of a conditional forgivable loan. If MN-S ceases to provide subsidized housing, then it will need to repay a portion of this funding. As of March 31, 2025, MN-S was contingently liable for \$498,547 (2024 - \$nil).

18. Commitments

i) In March 2021, MN-S entered into an agreement to provide funding to GDI for the administration of the Métis Nation - Saskatchewan Post-Secondary Education Program over the course of five fiscal years. MN-S is contractually committed to providing \$8,910,000 of funding per fiscal year to GDI for the fiscal years ending on March 31, 2026.

ii) In April 2024, MN-S entered into an agreement with Gabriel Dumont Institute (GDI) for the delivery and administration of the Indigenous Skills and Employment Training ("ISET") program. MN-S is contractually committed to providing \$13,994,649 of funding per fiscal year to GDI for the fiscal years ending on March 31, 2029. Pursuant to this agreement, MN-S entered into a formal agreement with the Minister of Employment and Social Development Canada and the Canada Employment Insurance Commission, where MN-S will receive annual funding of \$8,554,831 from the Consolidated Revenue Fund and \$5,439,818 under Part II of the Employment Insurance program for each fiscal year through to March 31, 2029.

19. Financial instruments

MN-S, as part of its operations, carries a number of financial instruments. It is management's opinion that MN-S is not exposed to significant interest, currency, credit, liquidity or other price risks arising from these financial instruments except as otherwise disclosed.

Credit risk

Credit risk is the risk of financial loss because a counter party to a financial instrument fails to discharge its contractual obligations. Financial instruments that potentially subject MN-S to credit risks consist primarily of cash and accounts receivable.

MN-S's cash is maintained at major financial institutions, therefore MN-S considered the risk of non-performance of these instruments to be remote.

Credit concentration

As at March 31, 2025, one customer accounted for 60% of accounts receivable. MN-S believes that there is no unusual exposure associated with the collection of these receivables, as the majority of the accounts receivable are directly related to funding agreements with the federal government and other funding agencies. MN-S performs regular credit assessments of its customers and provides allowances for potentially uncollectible accounts receivable.

Interest rate risk

Interest rate risk is the risk that the value of a financial instrument might be adversely affected by a change in the interest rates. Changes in market interest rates may have an effect on the cash flows associated with some financial assets and liabilities, known as cash flow risk, and on the fair value of other financial assets or liabilities, known as price risk. MN-S's exposure to interest rate risk is limited at this time.

Liquidity risk

Liquidity risk is the risk that MN-S will encounter difficulty in meeting obligations associated with financial liabilities. MN-S's exposure to liquidity risk is dependent on the receipt of funds from its operations, grants and other related sources. MN-S manages its liquidity risk by forecasting cash flows from operations and anticipating investing and financing activities to ensure it has sufficient available funds to meet current and foreseeable financial requirements.
